SCOPE OF WORK – Annexure-A

Name of Project: Supply, Installation, Testing, and Commissioning of Video Conferencing System at Vivekanand Sadan, Nightingale Hall in RFCL plant, Ramagundam.

Under present scope bidder has to supply items and it's all related accessories mentioned in Annexure-I to do complete execution of said project and successfully handover Complete Video Conferencing System to RFCL, Ramagundam.

I. Some salient points of scope of work:

- A. The bidder shall provide all the required equipment and services, whether explicitly mentioned in these specifications or not to fulfil the requirement of Video Conferencing System and to ensure the completeness, operation and maintainability of the system at no extra cost to RFCL. The bidder shall offer all the items which are compatible with each other. Successful completion of project is sole responsibility of the bidder.
- B. The complete Video Conferencing System inclusive of both hardware and software shall be under warranty for a period of **one year and thereafter one-year extended warranty**.
- C. The offered products in solution against supply order shall be latest version and shall not be end of life for next 5 years, however if any product which is declared end of life product by OEM during the supply period of material in this case tenderer shall supply replaced model or next higher model/version of the product.
- D. **Software's for the Video Conferencing System shall be customized as per RFCL's requirement.**
- E. The bidder shall provide in their offer; the make and model of each item being offered along with detailed technical literature and specifications sheet.
- F. The length of cables / quantities shown in Annexure-1 are tentative /indicative in nature. The material balance after completion of project shall be RFCL property while if any material falls short in completing the job, same shall be supplied by the bidder free of cost. At the time of execution of project, it shall be contractor's responsibility to ensure the completeness of system along with ensuring system reliable and convenient operability and its maintainability.
- G. The responsibility of complete Video Conferencing System, its signal quality and quality in work execution shall be Contractor's responsibility it should be to the satisfaction of Engineer in charge.
- H. The Installation & Commissioning of the equipment shall be done by the contractor (exact location shall be intimated at the time of site visit by the Engineer-in-charge).
- I. Material/manpower/ Tools/Instruments/hard wares required for such installation shall be arranged by the contractor.
- J. Integrated testing and commissioning of Video Conferencing System at RFCL site should be done.
- K. Installation will be as per BIS standards.

II. SPECIAL TERMS AND CONDITIONS

- 1. The system along with all auxiliaries and accessories shall be capable of performing intended duties under specified conditions. It is the responsibility of the contractor to supply the equipment as per NIT technical particulars and shall also guarantee the reliability and performance. Detailed literature along with make, model, datasheets, pamphlets and performance certificates as applicable shall be attached with your technical offer.
- 2. The System shall be designed by selecting high-grade components of proven quality and proper design of Video Conferencing System to ensure minimum down time.

3. Materials supplied and workmanship shall be of the proven quality and all work carried out to meet the requirements of IS codes of practice, I.E Rules.
4. The contractor shall ensure for the Video, Audio & Image clarity without any distortion.
5. All the special tools and tackles required for maintenance Video Conferencing System shall be in scope of the contractor. All equipment's and special cleaning solvents, brushes, special cloths etc for maintenance of Video Conferencing System to keep them clean and reliably workable conditions shall be specified and supplied by the contractor for first time.
6. The overall layout and installation of Video Conferencing System must be a hall mark of excellence. The quality and perfection of work shall have to be excellent. No compromise on quality of work shall be accepted
7. All technical data sheets of Video Conferencing System shall be provided. A detailed working manual and troubleshooting manual shall be provided.
8. The bidder must visit the site for any further clarification in respect of installation and commissioning with prior written request.
9. The cables shall be properly dressed and fixed. If any cable is to be laid on wall it shall be through PVC conduit and properly clamped.
10. Commissioning and warranty spares as mentioned in detailed scope of work shall be in the scope of contractor.
11. All Common Tools or Special devices, if any, are required for job, then the same shall be in contractor's scope.
12. Sub-contracting will not be allowed without written permission of RFCL.
13. You will make your competent and authorized engineer / personnel present during execution of work. Any abnormality arising during execution of job attributable to you shall have to be attended by you promptly at your cost.
14. Contractor shall take insurance of all his Engineers and workers deputed for job premises against worker's compensation act and with medical cover.
15. All the liabilities towards engineers and workers engaged by the contractor shall be with the contractor and it shall be responsible to fulfil the requirement of all the applicable acts of Telangana Govt or central Govt like minimum wages act, pf act and other welfare acts governing the regulation of contract labour. Contractor shall indemnify RFCL against all the defaults on this account.
16. All the engineers and workers shall bring their ID proof for the purpose of gate pass for entering inside RFCL Plant. If required CISF police verification certificate may also be required from nearest police station.
17. For Execution of work, Lodging and boarding shall be provided to the engineers on chargeable basis in RFCL Guest House depending upon the availability.
18. Contractor shall provide dust masks, earmuffs, safety shoes, helmets, hand gloves to workers deputed for job. No worker shall work at height without wearing full harness safety belts. All the PPEs are to be used while welding gas cutting drilling grinding and all other such jobs which may generally prove injurious if proper PPEs are not used.
19. Contractor will make own arrangement for the safety/security of the material brought for the job.
20. RFCL, shall provide unfurnished accommodation for the persons deputed by you for the job in RFCL township subject to availability and on payment basis. To & fro charges of deputed persons shall also be in contractor's scope.
21. Contractor will be required to submit 2 sets of test reports to RFCL within one month of completion of job.
22. RFCL will extend only First aid facility to the extent of its availability at site.
23. Work shall be deemed completed only after the successful commissioning of the system its successful demonstration, training of employees to operate system, its successful handover and running for one month without trouble and acceptance by RFCL engineer-in-charge.
24. All skilled as well as unskilled manpower shall be in contractor's scope and no help shall be extended by RFCL in this regard.

25. Temporary power required at site for execution of job and testing shall be provided by RFCL free of cost.
26. **Payment terms:** - Payment shall be done on successful completion of project Refer Sr. No 23 for successful completion means.
27. **Defect Liability Period:** Defect liability period shall be as per Guarantee/ Warranty Period from the date of completion of job for satisfactory performance of the work done by you. However, if any defect is observed during defect liability period, you will have to rectify the same free of cost. In case you fail to repair the damages within guarantee period, RFCL reserves the right to get the same done from any other agency at your risk and cost.

However, Special Terms will prevail over GTCC in case of any contradiction.

Scope of Work during warranty period of Video Conferencing System.

- a. Contractor should provide round the clock **onsite support** i.e. 24*7*365 days (including Saturday, Sunday and all holidays) for entire system including hardware and software in order to maintain the required uptime. All calls will be communicated to tenderer's local office through telephone or e-mail.
- b. Contractor must provide all the firmware and upgrades for entire system at no additional cost to RFCL. These upgrades and patches would be installed at RFCL Plant and when necessary.
- c. Contractor should provide Breakdown/preventive maintenance of the complete system.
- d. Contractor should provide Repair /replacement of all items including plastic components except consumables.
- e. The contractor shall provide regular preventive maintenance with a frequency of not less than once per quarter.
- f. Response time for resolving any problem of the entire system and making it operational is within 12 hours.
- g. The contractor shall maintain sufficient spare inventory of major components or complete units of entire system at all locations to achieve 99.9% uptime.
- h. In case of any item of the system is not repairable at site, then Contractor will provide a standby equipment of the same or higher configuration prior to carrying the item out of site. For this purpose, the Contractor shall maintain the details in the record sheet.
