

CORRIGENDUM-1 Dated 14th July'2023

In reference to the Tender reference cited above & Pre Bid Meeting held on 12th July'2023, following Corrigendum is being issued which shall be considered as an integral part of the original Tender:

(A) Corrective Action and Preventive Action (CAPA):

i. For First loss Dated 5 Dec 22 and Third loss Dated 29 May 2023

Corrective Action:

As a corrective action in both loss events, requisite welding was carried out.

Die Penetrating Test (DPT) and Radiographic Testing (RT) were conducted not only for affected joint but all other joints also. Pipe supports have been rectified/modified wherever necessary and additional support in outgoing steam pipe 20 inches at elbow (fixed support) to mitigate the possibility of transfer of vibration from pipes to manifold area. The Bottom lugs, which were found, damaged replaced with the modified lugs & clearances are maintained from fixed ends.

ii. Second Loss dated 19 Jan 2023:

Corrective Action:

Since Plant was taken for forced shutdown due to leakage in one of the Elbow, the same was replaced and after welding, DP & UT were carried out. All the joints together with the affected joint in the Synthesis pipe line were subjected to Post Heat Treatment followed by DP & UT again and plant was taken in line for operations once all the joints in Synthesis Line were thoroughly inspected and found to be fit for operation.

The plant is under uninterrupted operation with capacity utilization exceeding 100% since 19th Jun'2023 when it was taken in line, after forced shutdown on 31st May'2023.

The above shall form integral part of CLAIM HISTORY: "UNDER EXISTING MEGA OPERATIONAL POLICY" (Page No. 62).
