1.) Point 1 of Point A of Eligibility Criteria shall be read as.

The bidder should have executed at least one similar work in any large Fertilizers and Chemicals industries/Petrochemical/Power/Cement/Advanced Textile/Steel plants/PSU/any other organization as per scope of work given in NIT during last 7 years ending on prior to one month before the date of NIT with at least one work in last three years.

Similar work means work of supply, erection and commissioning of CCTV And Biometric system in any large Fertilizers and Chemicals industries/Petrochemical/Power/Cement/ Advanced Textile / Steel plants/PSU/any other organization.

**Note**: In case bidder doesn't have the work order consisting of both the CCTV And Biometrics work, for meeting experience criteria at point 2 of point A of eligibility crieteria, work orders of either CCTV or Biometric will be considered for the evaluation, subject to bidder has to submit the experience (work order/work completion certificate) for the other (CCTV/Biometrics) in the industries mentioned above. **For example**: If the bidder has submitted the experience in CCTV for the value mentioned in Point 2 of Point A of Eligibility Criteria, the same will be considered for evaluation provided the bidder has submitted the experience of the Biometrics Work in the industries mentioned above.

- 2.) Date in Point 2 of Point A of Eligibility Criteria shall be read as 31.03.2020 instead of 31.01.2020.
