1. Wherever in the bid document Intermediary/Broker/Intermediary/Direct Broker has been mentioned jointly or severally, the same stands modified as Broker/Intermediary/Direct Broker/Composite Broker/Consultant.
2. Following stands amended:

Bidders to also note that the documentary evidence required for evaluation under Sr. No. 4 of Table-1 and Sr. No. 4 of Form F-3 shall be submitted accordingly. Clause 1.1 (Technical Experience) under Sr. No. (ii) also stands modified accordingly. |

3. It is to clarify that clause 1.2 (Financial Position) under Sr. No. (ii) & under Sr. No. 7 of Table-1 and Sr. No. 7 of Form F-3, For computing Average Financial Turnover of Rs. 75 Crores, the turnover for all the three years shall be added for computing Average Turnover (to be divided by 3) which should not be less than Rs. 25 Crores.
4. Clause mentioned under Miscellaneous Provisions at Sr. No. (c) stands deleted.
5. Clause 1.6 (d) of Tender and in Form F-1, second para, text PSU stands replaced with PSUs/State Government Organizations/Central Government Organizations/Cooperatives. The period of 5 years mentioned therein stands revised to 3 (Three) years. Bidder to submit the Form F-1 on their letter head with aforesaid changes.
6. This Corrigendum shall become an integral part of the Tender and its acceptance (with signing and stamp by the Authorised Official of Bidder(s)) shall mandatorily be required otherwise the bid shall be liable for rejection.
