4. Pre-Requisites for Login Credentials:

For registration on the e-tender site https://www.tenderwizard.com/RFCL, one can be guided by the "Instructions to Vendors" available under the User Manual (Download) section of the homepage of the website. As the first step, bidder shall have to click the "Register" link and fill in the requisite information in the "Bidder Registration Form". Once you complete this process correctly, you shall get a system generated password and an email for verification. Thereafter, login in to the portal using your credentials. Digital Signature Certificate Class 3 Signing + Encryption is mandatory to attach at the time of Registration and to log-in. - **5.** All the vendors participating in the online e-procurement have to abide by the process involved in the entire workflow of the e-procurement.
- **6.** As a pre-requisite for participation in the tender, vendors are required to obtain a valid Digital Certificate of Class III (having both signing and encryption certificates) as per Indian IT A from the licensed Certifying Authorities operating under the Root Certifying Authority India (RCIA), Controller of Certifying Authorities (CCA). - VII) Bids/Offers shall not be permitted in e-procurement system after the due date time of tender. Hence, no bid can be submitted after the due date and time of submission has elapsed.
- VIII) No manual bids/offers along with electronic bids/offers shall be permitted except those specifically indicated.
