The pre-qualified vendors shall be eligible for participating in the tenders to be invited by RFCL subsequently for procurement of BAG CLOSING PP THREAD.

Applications are invited in prescribed format from reputed and experienced manufacturers of BAG CLOSING PP THREAD for pre-qualification. The performa for application can be also be downloaded from RFCL portal, www.rfcl.co.in.

The last date for submission of applications complete in all respects along with various documents is **21.09.2019** upto 5.00 pm. Applications received after this date or incomplete applications for any reason whatsoever may not be considered against this pre-qualification. Furnishing false / incomplete information or submitting applications not accompanied by required documents shall lead to summarily rejection of the application.

Firms already enlisted in NFL should also submit the application afresh in prescribed format with all supporting documents.

4.0 **Submission of Application**

4.1 All applications should be submitted in sealed cover duly super-scribed as "Application for Pre-qualification of Parties for Supply of HEAT SET Polypropylene Thread for closing of HDPE Bags" and shall contain the following self-attested documents:

4.2 Application duly filled in all respects and each page stamped and signed by the authorized signatory.

5.0 Compensation for submission of Application:

The applicants would not be entitled to claim any cost, charges or incidentals for or in connection with the preparation of and submission of their applications. However, RFCL may withdraw this invitation for pre-qualification or reject any or all the applications without assigning any reasons thereof.

6.0 Clear Understanding:

- 6.1 Pre-qualification is no guarantee for award of purchase order. Purchase Order will be awarded to the parties based on competitive price bid from the pre-qualified parties, which will be called for at a later date.
- 6.2 Pre-qualification will be valid for a period of three years, which will be at the sole discretion of RFCL.
- 6.3 Pre-qualification of a vendor will depend on the competence of the party to supply the required category of items, based on the documents / information submitted by party and as assessed by RFCL at their sole discretion.
- 6.4 Furnishing of False/Incomplete Information with the application would lead to disqualification.

RFCL Acceptance on the Letter Head of Party duly has signed Memorandum of understanding (MOU) for implementation of signed and stamped shall be submitted along Integrity Pact with Transparency International with their application. India. Only those vendors/bidders who enter in to such Integrity Pact with RFCL, qualifies to participate in the bidding process. Vendors who confirm unconditional acceptance to sign Integrity Pact Agreement (Format enclosed) shall only be considered for prequalification.

8 Bidder should also submit following documents along with above eligibility documents:

- a) Authenticated copy of party's status i.e. self-certification on letter head in case of proprietorship firm or copy of partnership deed for a partnership firm or copy of registrar's certificate for Pvt./Ltd. Co. The partnership deed should be duly notarised with current date should be submitted by the applicant who is applying under name & style of Partnership Firm.
- b) Self-Certified copy of PAN No. issued by Income Tax Department.
- c) Self-Certified copy of GST registration issued by related Department.
- d) Vendors shall furnish details as per Annexure I, along with supporting documents.
- e) The pre-qualification will be valid for three years and is extendable for a further period of one year, at the sole option of RFCL.
- f) Only one Company out of sister concerns under the same management/group shall be considered for pre-qualification. However, more than one Unit/Plant of that concern may be considered for supply provided it meet(s) all conditions independently w.r.t. minimum capacity and all other infrastructural facilities as mentioned at Annexure-'A'. In case more than one Unit is considered for pre-qualification, the combined capacity of all such Units shall be considered as assessed capacity of that vendor.

SPECIFICATIONS OF THE POLYPROPYLENE THREAD FOR CLOSING OF 45 Kg CAPACITY FERTILIZER HDPE BAGS

High Tenacity Polypropylene Multifilament Twisted bag closing thread with heat set

Denier : 1200+/-5%
Construction : 210D/3x2
Basic Yarn Denier : 210 D+/-5%
Breaking Strength : 6 Kg & above

Packing Size : Approx. 800 gms/ 1 Kg on Jumbo Card Board Cones with

Plastic Disc insertion

Colour : Natural White
Length per Kg : 7400 Mtrs. +/- 5%
Cone Length : 230 mm (Min.)
Runnage : 7150 Mtrs. Per Kg
Ply Twist : 280 TPM. S-way
Cable Twist : 240 TPM- Z way

Notes:

- 1. Packing of each cone in antis tough, off shrink-wrap with logo printed on the film for identification.
- 2. Jumbo cardboard should be left empty by about one inch length from top & bottom and top empty space should be laminated.
- 3. Material should be packed in compartment type hard cardboard boxes in single stacking such a way that it does not get damaged / pressed during transit and boxes should be covered with gunny wrapper. If due to poor packing the material get damaged/pressed during transit the same shall be replaced by you.
